

2005 PALM BEACH CAJUN BLUES CRAWFISH FESTIVAL

VENDING RULES

1. **Set Up** Vendor set up is scheduled for Saturday, April 2, 2005, beginning at 9:00 a.m. All vehicles, trailers, and other vending equipment must be set up and removed from show site by 2:00 p.m. This will allow for a safety and fire code inspection at approximately 2:30 p.m. Gates open at 3:00 p.m. thru 11:00 p.m.
2. **Safety** You are solely responsible for complying with all safety, health, and fire code requirements. You must have a fire extinguisher at your location if you are dealing with any electronic, cooking, or grilling equipment. All propane tanks, charcoal, or any other form of fuel used for cooking of food must be outside of the tent. Any electrical cords or water hoses must be picked up or use cable ramps for the safety of the general public.
3. **Water & Electrical Hook-Up & Ice-** You are responsible for supplying all power cords and hoses which may be required to connect to suitable power and water. We will have an electrician on site for your assistance. Water hook -ups are available at no charge. We will have ice on the premises available for your purchase/convenience. Additional electric will be available at an additional cost.
4. **Indemnification and Insurance**. The vendor hereby agrees to carry and keep in full force and effect at all times during which vendor will be operating at the event, general liability insurance, including products liability insurance, in an amount of not less than one million dollars for general liability . Said coverage shall include the Palm Beach Cajun Blues Crawfish Festival as **additionally named insured** in an amount of not less than one million dollars against any damages, lawsuits, or claims arising out of any injuries or accidents cause by your activities.
5. **Restricted Products**. The Palm Beach Cajun Blues Crawfish Festival has granted an exclusive vending opportunity with respect to all beer, wine, bottled water, sodas and alcohol. You may not sell any such beverages. No exceptions will be made to this policy, and all vendors must refrain from selling restricted items.
6. **Exclusivity**. The Palm Beach Cajun Blues Crawfish Festival is able to guaranty any exclusivity or restrictions on the number of vendors or the type of products sold. You will be assigned a space based upon the judgment of the Palm Beach Cajun Blues Crawfish Festival, and no locations are guaranteed. We will certainly do our best to provide you with a convenient and suitable space for the sale of your products.
7. **Conduct**. The Palm Beach Cajun Blues Crawfish Festival is a family oriented event. You should refrain from selling any products which would offend children or which would otherwise not fit the format of this type of function. You are responsible for controlling your employees, and all vendors must conduct themselves in a courteous and polite manner. Our image is important to us and I know that it is important to your company and by following these simple procedures, we will all benefit.
8. **Clean-Up**. All vending materials must be removed from the park no later than Sunday, April 3, 2005 at 2:00 a.m. **You are responsible for removing all debris and cooking materials (coals, etc.) from the site.** Dumpsters are on-site for your use.
9. **Security**. Will provide security beginning April 2, 2005 at 8:00 a.m. and continuing April 3,2005 until 6:00 a.m. The event site is completely fenced and gated and each gate will have a security guard for access. While such security is provided, the Palm Beach Cajun Blues Crawfish Festival, shall not be responsible for any stolen, lost, or damaged items of equipment or personal belongings. You shall be solely responsible for the protection and safeguarding of valuables and release the Palm Beach Cajun Blues Crawfish Festival, from any losses or damage to your property.

10. **State laws.** The vendor hereby agrees to abide by all applicable Federal, State, County and City laws and regulations and be responsible for obtaining and/or possessing any and all permits and licenses that may be required including food handling permits and Department of Revenue license. State Health Department regulations must be strictly complied with. Failure to pass inspection by any regulatory authority you can not serve or sell to the general public.

11. **Sales Tax** You are responsible for paying all appropriate sales tax for the sale of food or merchandise sold at the Palm Beach Cajun Blues Festival. The sales tax in Palm Beach County is 6.5%.

12. **General Provisions** All vending fees are nonrefundable. Your payment of the entry fee constitutes your right to participate at the Palm Beach Cajun Blues Crawfish Festival. Should any entry fees not clear our account or not be paid in full, you have no right to participate at the event.

13. **Vendor Passes.** Prior to the event, we will mail to you (based on the information provided in your application) vendor I.D. wristbands for the event. Please insure that all employees wear the appropriate vendor I.D. wristbands at all times. Due to the fact that this event takes place in downtown West Palm Beach, parking is at a premium we can assist you in parking your vehicle upon request at an additional cost

14. **Entry.** You may enter the show site by vehicle at the north and south entry gates, but all traffic must end one hour prior to our opening times. Vendors may enter the south gate, during the event to restock your supplies. Please be sure that all employees wear their vendor I.D. wristbands

15. **Sublet or Transfer** The Vendor shall not sublet, transfer, convey, assign nor permit the use of the rights, privileges or promises granted under this agreement in whole or part to any other person, firm or organization.
